**ARTICLES OF INCORPORATION**

The undersigned Incorporator, Diane Rue, whose post office address is 244 Shopping Avenue, #293, Sarasota, Florida 34237, being at least eighteen (18) years of age and for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**Article 1      NAME**

The name of the corporation shall be:

IronOnLabels.com Co.

**Article 2      PRINCIPAL OFFICE**

The principal place of business and mailing address of the corporation shall be:

**Article 3      SHARES**

THE CORPORATION SHALL NOT BE AUTHORIZED TO ISSUE CAPITAL STOCK.

**Article 4      INITIAL REGISTERED AGENT AND STREET ADDRESS**

**Article 5      PURPOSE OF THE CORPORATION**

The purpose for which the corporation is formed are:

1. To engage in the business of sale and resale of labels for textile identification, heat sealing, labeling and mending and personal articles; and
2. To carry on any other business in connection with the foregoing or otherwise; and
3. To acquire (by purchase, lease, or otherwise), own, hold, use, alter, repair, lease or mortgage, sell or otherwise dispose of real property, or any interest or right therein, wherever situated, within or without the State of Florida; and
4. To organize incorporate and reorganize subsidiary corporations, joint stock companies, and associations for any purpose permitted by law; and
5. To do any act or thing and exercise any power suitable, convenient or proper for the accomplishment of any of the purposes enumerated herein or incidental to the powers specified herein, or which at any time may appear conducive to or expedient for the accomplishment of any such powers.

**Article 6 DIRECTORS**

The number of directors of the Corporation shall be one (1), which number may be increased or decreased pursuant to the bylaws of the Corporation, but shall never be less than one (1).

The name of the director who shall act until the first annual meeting or until her successor is duly chosen and qualified is Diane Rue.

**Article 7 CORPORATION INDEMNIFICATION**

The corporation may indemnify a present or former director or officer of the Corporation or other corporate representative to the maximum extent permitted by in accordance with the Business and Corporations Act, Florida Statutes.

**Article 8 EFFECTIVE DATE**

The effective date of the corporation shall be July 1, 2000.

**Article 9 DURATION OF THE CORPORATION**

The duration of the corporation shall be perpetual.

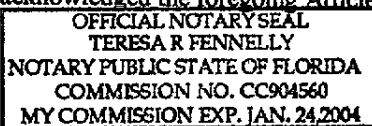
