ARTICLES OF INCORPORATION
OF
DIEZ ANTILLA INC.

ARTICLE I - NAME

The name of this corporation is DIEZ ANTILLA INC.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the date of filing.

ARTICLE III - PURPOSE






