1. NAME. The name of this corporation is AIRPORTAMERICA.COM., INC.
2. EFFECTIVE DATE: The effective date of commencement of this corporation is June 20, 2000 and it shall have perpetual existence
3. PURPOSE. This corporation is organized for the purpose of transacting any and all lawful business.
4. CAPITAL STOCK. This corporation is authorized to issue Five Hundred (500) Shares of One (\$1.00) Dollar par value common stock, which shall be designated "common stock".
5. PREEMPTIVE RIGHTS. 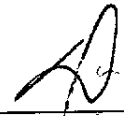
