The name of this corporation is Florida Sea Farms, Inc.

This corporation is authorized to issue ONE HUNDRED (100) shares of \$1.00 par value common stock and same shall be of a single class.


ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT
