## ARTICLES OF INCORPORATION

OF

COOL COAT, INC.



The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

## **ARTICLE ONE**

The name of the corporation is: **COOL COAT, INC.**The principle address of the corporation is: 290 N.E. 5th Ave., Delray Beach, FL 33483.

#### **ARTICLE TWO**

This corporation shall commence its existence upon filing and shall exist perpetually thereafter unless sooner dissolved according to law.
