**ARTICLES OF INCORPORATION
OF**

UECO, Inc.

The undersigned, acting as incorporator of this corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under The laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

ARTICLE I – NAME OF CORPORATION

The name of this corporation shall be UECO, Inc.

ARTICLE II – PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 7616 Southland Blvd., Suite 108, Orlando, Florida 32809.

ARTICLE III – TERM OF EXISTENCE

This corporation shall exist Perpetually.

ARTICLE IV – GENERAL PURPOSE

The general purpose for which this corporation is organized shall be:

1. To manufacture, construct, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with products, goods, wares, merchandise, real and personal property and services of every kind, class and description.

2. It is intended that this corporation is organized for and may conduct and transact any an all lawful business authorized and not prohibited by Chapter 607, Florida Statutes, as the same may be from time to time amended; provided, however, And notwithstanding the generality of the foregoing, this corporation is not to conduct a banking, safe deposit, trust, insurance, surety, express, building and loan association, fraternal benefit society, state fair or exposition business.

ARTICLE V – CAPITAL STOCK

1. The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any time is 100 shares shares of common stock having a par value of \$1.00 per share.

2. The corporation shall have the first right of refusal to buy back any outstanding shares issued, at par value.

AND REGISTERED AGENT**

The corporation shall indemnify any registered agent, officer, director, or Incorporator, or any former registered agent, officer, or director, to the full extent Permitted by law.

ARTICLE XI – SHAREHOLDERS PREEMPTIVE RIGHTS

Every shareholder of voting stock shall have the preemptive rights to purchase His share of the issuance of any class stock, including treasury stock, at the price Offered in proportion to his holding of stock.
