

**ARTICLE I - CORPORATE NAME**

The name of this corporation is MOONLIGHT MAINTENANCE SERVICE, INC., whose principal office address is 3821 Long Leaf Drive, Melbourne, Florida 32940 and mailing address is P. O. Box 410828, Melbourne, Florida 32941.

**ARTICLE II - NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III - CAPITAL STOCK**






