Article I. The name of the corporation shall be *5-Star International Food Corporation, Inc.*

Article II. The mailing address of the corporation is *3200 Arden Villas Blvd. #13, Orlando FL 32817*

Article III. The corporation shall have the authority to issue the following stock:

1. Voting: 10,000 shares of voting common stock having a par value of \$0.01 per share.
2. Non-Voting: 10,000 shares of non-voting common stock having a par value of \$0.01 per share.

- (2) Kil Soo Cha 60(Shs) Voting Stock 60%


Article VII. The initial Board of Directors shall consist of the following:


