BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under the laws of the State of Florida.


1. The name of the corporation is Swickle, Thomas & Rosenblum, P.A.
2. This corporation shall exist perpetually.
3. The purpose of this corporation is to provide legal services through the operation of a law firm and to exercise the powers now or hereafter granted to professional service corporations.
4. This corporation is authorized to issue 240 shares of common stock.

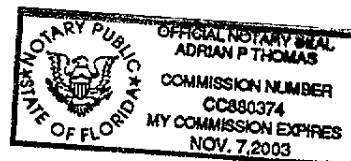


