The initial registered agent of the corporation is:

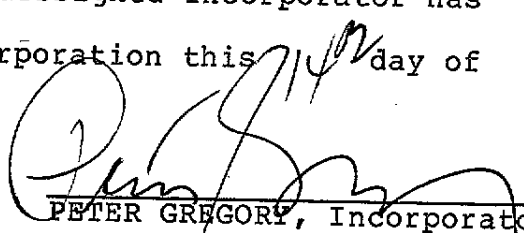

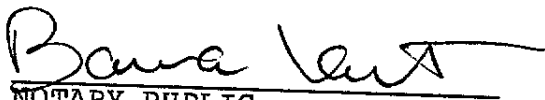
