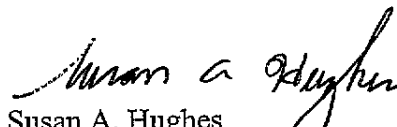

**ARTICLES OF INCORPORATION
OF
CYNTHIA L. COLLAWN, M.D., P.A.**

ARTICLE I - NAME

The name of this Corporation is: CYNTHIA L. COLLAWN, M.D., P.A.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida. The specific purpose is the practice of medicine.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$1.00 per share.

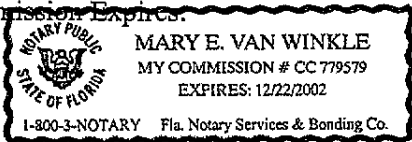

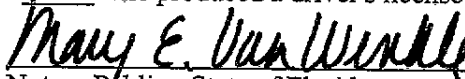

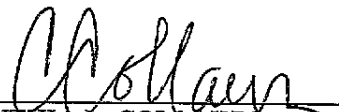
