ARTICLES OF INCORPORATION
OF
FORMS CORPORATION

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation (hereinafter called the "corporation") shall be: FORMS CORPORATION.



and other real, personal, and mixed property of any and all kinds, together with the components, resultants, and by-products thereof.


To do any and all other powers which a copartnership or natural person could do and exercise and which now or hereafter may be authorized by law.

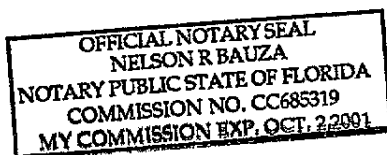




