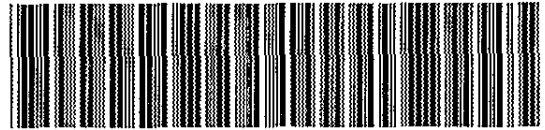

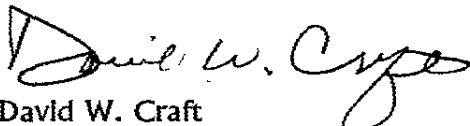

Pursuant to F.S. Sec. 607.1006, this corporation adopts the following articles of amendment to its articles of incorporation:

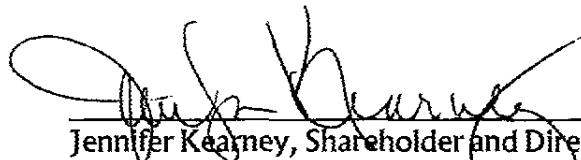
1. ARTICLE ONE of the Articles of Incorporation is amended to read as follows:
