CERTIFICATE OF INCORPORATION

ARTICLE I

NAME.

The name of this Corporation shall be:

TAMIAMI OIL SERVICE LUBE, INC.



ARTICLE II

NATURE OF BUSINESS

This Corporation may engage in any activity of business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE III

 Required percentage => 51%
- 3. Merger or consolidation of this Corporation into or with any other Corporation:

 Required percentage ==> 51%
- 4. Voluntary dissolution of this Corporation:

Required percentage ==> 51%


