We, the undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby associate ourselves to form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is Genesis Marketing Research, Inc.

ARTICLE II - PURPOSE AND NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida. The nature of the business of the corporation and the objectives and purposes to be transacted shall be:

- (a) That the corporation shall be formed for the purposes of providing marketing research services throughout the State of Florida to the general public;
- (b) To borrow, execute notes, mortgages and deeds, or other evidence of indebtedness, and to secure the same by pledge or otherwise, of any and all of the products or assets of the corporation for any purpose necessary or expedient in the operation of said businesses;
- (c) To do all things that may become necessary, expedient in the proper conduct of the business functions of the corporation;
- (d) To associate or create any other lawful business or businesses or to create subsidiaries for the operation of the same within the laws of the State of Florida and the United States of America.

ARTICLE III - EXISTENCE OF CORPORATION

The duration of this corporation shall and will be perpetual unless sooner dissolved by law.

ARTICLE IV - PRINCIPAL OFFICE

The address of the principal office is 2124 West Kennedy Boulevard, Suite C, Tampa, Florida, 33606.

ARTICLE V - CAPITAL STOCK

The aggregate number of shares of stock which this corporation shall have the authority to issue shall be one thousand (1000) shares of common stock at no par value.

ARTICLE VI - REGISTERED AGENT

ARTICLE VII - DIRECTORS

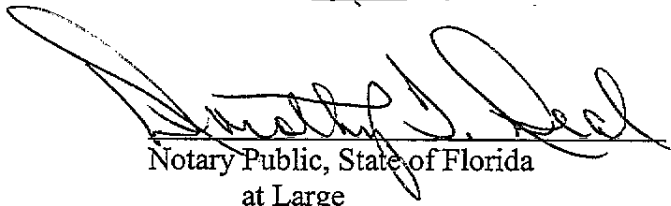
