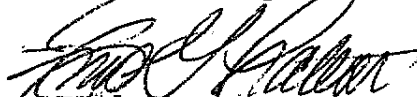

OF

The name of this corporation shall be CRISGAR CORPORATION.

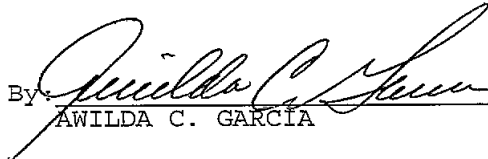
