

This letter is in response to your Notice of Administrative Dissolution or Revocation effective September 21, 2001. The original Uniform Business Report was filed in April, 2001 and was not processed as filed by your office. The explanation was for not filling in box (4) Federal I.D. number. The Federal I.D. Number had not been received at that time. Upon receipt of their E.I. number, they filled in the box (4) on their copy of the report and forwarded a check and the completed form to your office on May 24, 2001. By your Notice of Dissolution, it is evident that you never received my client's filing.

At this time we are sending the Application for Reinstatement, with a check in the amount of \$150, which covers their 2002 UBR. At this time we are requesting an abatement of the penalties that can be assessed due to my client's late receipt of their Employer Identification Number from the Internal Revenue Service.
