# ARTICLES OF INCORPORATION OF JACKSON LANDSCAPING OF CENTRAL FLORIDA, INC.

ACKSON he Florida

THE UNDERSIGNED, acting as sole incorporator of JACKSON LANDSCAPING OF CENTRAL FLORIDA, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

# ARTICLE I

#### Name

### **Initial Board of Directors**

The person who is to serve as initial Director until the first annual meeting of the shareholders of the corporation or until such successor Directors are elected and shall qualify is Clayton Jackson.
