
As per our telephone conversation of today, enclosed please find the following documents:

Hoping that you will make these corrections so these errors will not repeat themselves in the 2003 UBR request for payment, I remain.

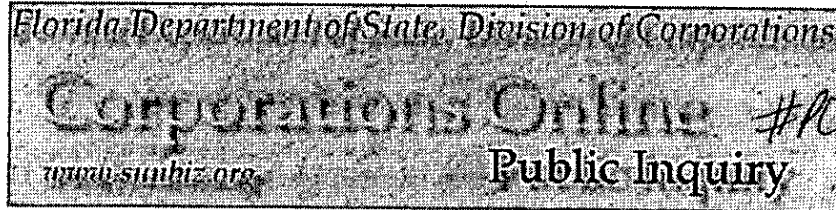
