ARTICLES OF INCORPORATION **OF**

SECRETARIA PHE 19 The undersigned incorporator makes, subscribes, acknowledges and files with the Department of State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of State of Florida.

ARTICLE I

The name of the corporation is TROPIC EXTERIOR REMODELING INC.

ARTICLE II TERM OF EXISTENCE

This corporation shall commence as of the date of filing of these Articles of Incorporation with the Secretary of State and shall have perpetual existence.

ARTICLE III NATUREOF BUSINESS

The purpose for which this corporation is organized is to engage in all lawful business for which corporations may be incorporated under the laws of the United State of America and of this State.

ARTICLE IV CAPITALSTRUCTURE
