**ARTICLES OF INCORPORATION
OF
NEWBY ASSEMBLY SOLUTIONS, INC.**

I, the undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the Laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be: **NEWBY ASSEMBLY SOLUTIONS, INC.**

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be:

ARTICLE III - DURATION



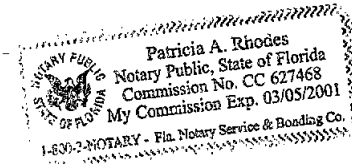
