# Articles of Incorporation of AHN Realty, Inc

#### I. Name

The name of the Corporation is AHN Realty, Inc, hereinafter referred to as the "Corporation."

### II. Purposes

The purpose of the Corporation is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time.

### III. Principal Office and Registered Agent

The Corporation may maintain offices and/or transact business at other locations, either within or without the State of Florida. ### IV. **Duration**

The duration of the Corporation shall be perpetual.

### V. Initial Business

The initial business of the Corporation shall be:

The Auction of property and any other service of real estate as laid out by the Florida Real Estate Commission under the rules of the Department of Business and Professional Regulation.
