WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

- FIRST:** The name of the corporation is 2nd CAVALRY TOWING & RECOVERY, INC.
- SECOND:** The period of its duration is Perpetual
- THIRD:** The purpose(s) for which the corporation is organized are "To operate a towing business and any other lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes."

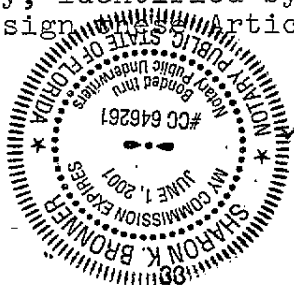
