ARTICLES OF INCORPORATION OF  
FORUM TRUCKING CO.

FIRST: The name of the corporation is FORUM TRUCKING CO. (the "Corporation").

SECOND: The street address of the initial principal office is 5200 S. Washington Avenue,  
Titusville, Florida 32780.

THIRD: The number of shares the Corporation is authorized to issue is 10,000 shares of  
Common Stock, \$.01 par value per share.

No shareholder shall be entitled as a matter of right to subscribe for or receive additional shares  
of any class of stock of the Corporation, whether now or hereafter authorized, or any bonds, debentures  
or other securities convertible into stock, but such additional shares of stock or other securities  
convertible into stock may be issued or disposed of by the Board of Directors to such persons and on  
such terms as in its discretion it shall deem advisable.

FOURTH: The street address of the initial registered office of the Corporation is C/O CT  
Corporation System, 1200 South Pine Island Road, Plantation, Florida 33324, and the name of the initial  
registered agent at such address is CT Corporation System.
