

**ARTICLES OF INCORPORATION  
OF**

**ARTICLE 1. - NAME**

The name of the corporation is P-Z SARASOTA, INC.

**ARTICLE 2. - PRINCIPAL OFFICE**

The principal office of the corporation shall initially be at 501 North Beneva Road, Suite 636, Sarasota, FL 34232. The corporation may change its principal office from time to time as permitted by law.

**ARTICLE 3. - MAILING ADDRESS**

The initial mailing address of the corporation shall be 501 North Beneva Road, Suite 636, Sarasota, FL 34232. The corporation may change its mailing address from time to time as permitted by law.

**ARTICLE 4. - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE 5. - SHARES**

This corporation is authorized to issue 10,000 shares of voting common stock with a par value of \$1.00 per share.

**ARTICLE 6. - INITIAL REGISTERED OFFICE AND AGENT**
