RINCON, D.O., P.A., a professional service corporation under Chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME AND ADDRESS

The name of the corporation is WILLIAM G. RINCON, D.O., P.A. The principal business address of the corporation is 12601 World Plaza Lane, Suite 1, Fort Myers, Florida 33907.

ARTICLE II. NATURE OF BUSINESS

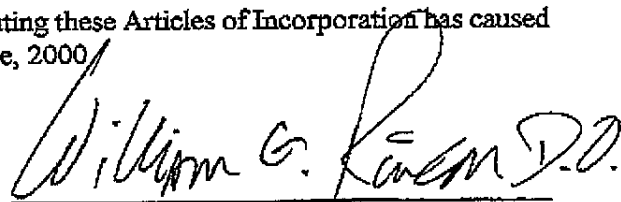
