**ARTICLES OF INCORPORATION

The undersigned incorporator hereby forms the following Corporation under the laws of the State of Florida.

**ARTICLE I:
NAME**

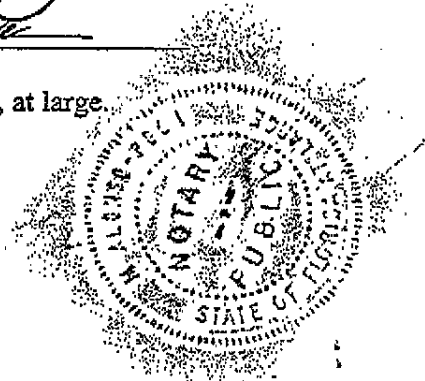
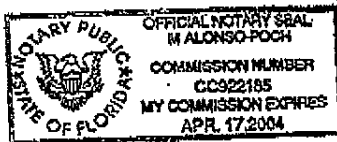
