The undersigned subscriber to these Articles of Incorporation, Douglas Kubik, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

#### ARTICLE I

#### **CORPORATE NAME**

The name of this Corporation is DOUGLAS KUBIK, INC. The principal office and mailing address of the corporation is 207 San-Mateo Drive, Bonita Springs, Florida 34134.

#### ARTICLE II

#### **DURATION**
