
To whom it may concern:

I have a situation I'm hoping you can resolve for me. A new client of mine has informed me that my corporation, CyberWrite, Inc., has been administratively dissolved. Upon this notification I realized that I did not pay my annual UBR filing fee of \$150.00. When I thought about this I realized I did not receive the filing package from your office. The problem, I realize in retrospect, is twofold. First off, the residential property next to mine was being leased out to a person who has a corporation – Thomas Chadwick, All 4 Seasons Inc. – and he was using my address and receiving my mail. I, in turn was receiving his mail. Attached, I am providing proof of this with a letter sent to him at my address. I have other examples if necessary. Please note there is no "#B" as indicated in the address, as all of the properties in my neighborhood are one (1) unit per acre and it is strictly residential. Secondly, because my business is so small and I have very little annual paperwork – UBR Filing and business license – I did not look forward to the form being sent to me. Also, I have only done this twice before because I have only been in business for three (3) years, so you can understand my not expecting the form.

At this time, I am urging you to waive the penalty so that I may continue doing business under CyberWrite, Inc. Enclosed, you will find a check for \$150.00 to pay for the UBR Filing.
