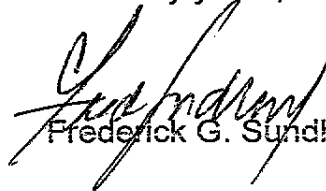

ARTICLES OF INCORPORATION

OF

TRUMBULL HOUSE, INC.

ARTICLE I. NAME

The name of this corporation shall be TRUMBULL HOUSE, INC.

ARTICLE II. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE III. NATURE OF BUSINESS

The general nature of the businesses to be transacted by this corporation is for interior design and for the purpose of transacting any and all lawful business.
