### ARTICLE III - PURPOSES

The Corporation is being formed for the general purpose of conducting any and all business for which corporations may be incorporated under the laws of the State of Florida.

(4) <u>To Act as Agent.</u> To act in any state which the corporation is qualified to do business, as agent or representative for any individual, association, corporation or legal entity, respecting business which the Corporation is authorized to transact.

- (5) <u>To Make Contracts</u>. To enter into, make, perform, and carry out, or cancel and rescind, contracts for any lawful purposes pertaining to it's business.
- (6) <u>To Deal in Patent Rights.</u> To acquire, (by purchase, exchange, lease, hire or otherwise) hold, use, sell, lease, assign or grant licenses or sub-licenses in respect of, pledge or otherwise dispose of, letters patent of the United States or any foreign country, patent rights, licenses, privileges, invention, improvements, processes, copyrights, trademarks and trade names.
- (7) <u>To Deal in Good Will.</u> To acquire, (by purchase, exchange, lease, hire or otherwise) all, or any part, of the good will, rights, property and business of any person, entity, partnership, association, or corporation heretofore or hereafter engaged in any business similar to any business which the Corporation has power to conduct; to pay for the same in cash or in stocks, bonds or other obligations of the Corporation or otherwise; to hold, utilize and in manner dispose of the whole, or any part, of the rights and property so acquired, and to assume in connection therewith any liabilities of any person, entity, partnership, association, or corporation, and conduct any lawful manner the whole, or any part, of the business thus acquired.

- (14) <u>Construction of Foregoing Sections.</u> The foregoing sections shall be construed as purposes as well as powers and the matters expressed in each Section shall, unless otherwise expressly provided, be in no way limited by reference to, or inference from, the terms of any other section, each such Sections being regarded as creating independent powers and purposes.
