ARTICLES OF INCORPORATION

OF

SEBAHAR CORP.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is:

In the event these Articles of Incorporation are not filled within the time period set forth in Section 607.0203, Florida Statutes, the date when corporate existence shall commence is the date of filling by the Secretary of State.
