

# **Articles of Incorporation**

**for**

## **D.M.E. FUNDING INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

### **ARTICLE I.** **NAME**

The name of the Corporation is: D.M.E. FUNDING INC.

### **ARTICLE II.** **DURATION**

The term of existence of the Corporation is perpetual.

### **ARTICLE III.** **NATURE OF BUSINESS**

The nature of the business to be conducted by the Corporation is:
