## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF GLOBAL DEVELOPMENT NETWORK, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

## Article I - Name

The name of the corporation is GLOBAL DEVELOPMENT NETWORK, INC. (hereinafter referred to as the "Corporation").

## Article II - Adoption and Text of Amendments

The Board of Directors of the Corporation approved a resolution amending Article III of the Articles of Incorporation in a meeting held on July 13, 2000 and the shareholders unanimously approved the resolution amending Article III of the Articles of Incorporation in a meeting held on July 13, 2000. The following is a true and correct copy of the resolutions amending Article 3 of the Articles of Incorporation:

RESOLVED, that Article III of the Articles of Incorporation of the Corporation be amended in its entirety to read as follows:

### Article III - CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is one million (1,000,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

The effective date of the amendment to the Articles of Incorporation of the Corporation set forth herein will be as of the date of filing the Articles of Amendment to the Articles of Incorporation with the Secretary of State of the State of Florida.
