ARTICLE I
CORPORATE NAME

ARTICLE II
DURATION

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

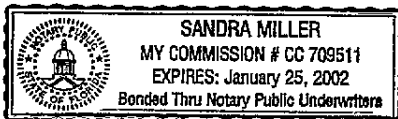
