

ARTICLE NINE - INDEMNIFICATION



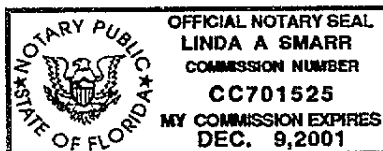
