ARTICLES OF INCORPORATION OF CABANA BOY, INC.

ARTICLE I

Name. The name of this corporation is CABANA BOY, INC.

ARTICLE II

Duration. The corporation shall be perpetual.

ARTICLE III

<u>Purpose.</u> This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV

<u>Capital Stock.</u> This corporation is authorized to issue 100 shares of common stock at \$1.00 par value, which shall be designated "Common Shares."

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.
