
ARTICLE THIRTEEN

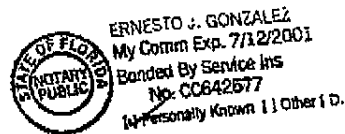
