The name of this corporation shall be Showcase Mortgage Corporation.

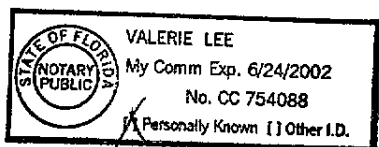



