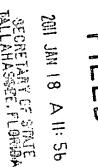

Pursuant to the provisions of Sections 607.1003 and 607.1006, Florida Business Corporation Act (the "Act"), FIRST HOME BANCORP, INC., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

<u>Amendment</u>
