

**ARTICLE OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
FIRST HOME BANCORP, INC.
(name change amendment)**

Pursuant to the provisions of Sections 607.0704, 607.1001, 607.1003, 607.1004, and 607.1006, Florida Statutes, First Home Bancorp, Inc. adopts the following Article of Amendment to its Articles of Incorporation:

Article I of the Articles of Incorporation is hereby amended to read:

ARTICLE I

The name of the corporation shall be BayFirst Financial Corp.

The foregoing amendment was adopted by affirmative vote of a requisite number of the holders of the outstanding shares of common stock of the Corporation, which was the only class of stock entitled to vote pursuant to a Written Consent to Action, dated between April 13, 2021 and April 21, 2021.
