

(ASSIGNMENT OF STOCK)


No shareholder of this corporation may assign or sell shares in contravention of any provisions in the by-laws or shareholders agreement of the corporation.

(INDEMNIFICATION)

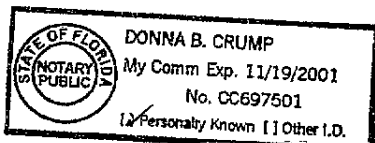




