ARTICLES OF INCORPORATION OF

THE TRIO GROUP, INCORPORATED



The undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the laws of the State of Florida.

Article I- Corporate Name

The name of the corporation shall be The Trio Group, Incorporated.

Article II- Duration

The corporation shall exist perpetually unless dissolved according to the laws of the State if Florida.

Article III- Purpose
