NAME

The name of this corporation is Bogey Sports, Inc.

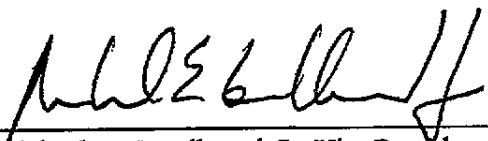
