I had resigned as an officer of the above referenced corporation as of 1/1/2000, and no longer a stockholder effective the same date, this is the reason why I am writing to you this late.


The company has steadily declined over the past three-year period due to the poor health of the President, Lawrence C. Murphy. He is consistently in and out of the emergency room with his medical condition. I have only been helping Lawrence Murphy file the necessary reports and returns as they come due. He has not had any employees in the Company for the past two years.

As the original check indicates, the check and annual report were completed on April 22, 2001 and sent to Lawrence Murphy for signature (I live in Wisconsin, Lawrence Murphy lives in Florida).
