



AMENDMENTS





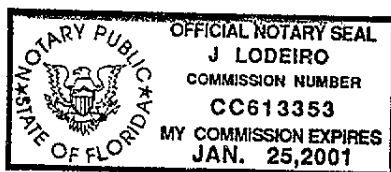
