

ARTICLES OF AMENDMENT OF FULL SAIL, INC.



The undersigned, EDWARD E. HADDOCK, JR., being the President of FULL SAIL, INC., does hereby certify that the following Amendment to the Articles of Incorporation of FULL SAIL, INC. was approved by the Stockholders of the Corporation on the ______ day of November, 2000, at a duly called meeting of the Stockholders and Directors of the Corporation.

The Articles of Incorporation of FULL SAIL, INC., are hereby amended as follows:

1. Article is hereby deleted and the following is inserted in lieu thereof:

ARTICLEI

- 1. The name of the corporation shall be **FULL SAIL RECORDERS**, **INC**.
- 2. All amendments included herein were adopted pursuant to Section 607.1006, F.S., and there is no discrepancy between the Corporation's Articles of Incorporation as theretofore amended other than the inclusion of these amendments and the omission for matters of historical interest.
- 3. This Amendment has been approved by unanimous consent of all of the Shareholders of the Corporation who are entitled to vote.
- 4. This Amendment shall be effective upon its filing with the Secretary of State, State of Florida.
