ARTICLES OF INCORPORATION

of

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms an "S" corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of the "S" Corporation shall be: **Michelle Undorf, P.A.**

The principal place of business of this "S" Corporation shall be at 111 Moody Avenue, Tampa, Florida, 33609.

ARTICLE II NATURE OF BUSINESS
