The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is GOLF MAX BUSINESS SOLUTIONS, INC.

ARTICLE II

The principal office of the corporation is 2327 Premier Drive South, St. Petersburg, Florida 33707.

ARTICLE III

The period of duration of the corporation is perpetual.

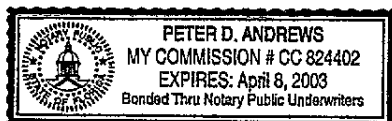


