ARTICLES OF AMENDMENT OF JAD INFORMATION SERVICES, INC., a Florida corporation

- 1. The following provisions of the Articles of Incorporation of JAD INFORMATION SERVICES, INC., a Florida corporation, originally filed in Tallahassee on the 23rd day of June, 2000, and as amended on the 14th day of August, 2000, be and the same is hereby further amended as follows:
 - (i) That Article IV, Capital Stock, be deleted in its entirety.
- (ii) That Article IV, Capital Stock, should be and the same is hereby, replaced in its entirety which shall read as follows:

"ARTICLE IV

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000,000 shares of common stock, having par value of One Cent (\$.01) per share."

2. That this Articles of Amendment were approved by the Shareholders and Directors of the corporation by Written Action effective the 1st day of April, 2001.
